Local Business Agent, Chris Czubakowski:

The national APWU negotiating team did a great job in securing a tentative agreement with the company which I hope all our members will vote in favor of. We maintained or gained more contractual rights without having to give any concessions. In this day in age this is unheard of. One of the rights we maintained was that the company will continue to pay 95 percent of the premium for APWU members enrolled in the APWU consumer driven health plan. This plan is hands down the best insurance plan available to postal workers. Premiums for Consumer Driven are: Self is 16.12 per PP, Self and Family is 38.23 per PP, Self Plus One is 35.05. Open season will be here in November.
